**A member has the option of pre-paying his/her annual dues in a single payment. If you wish to do this, contact the MSCF office immediately.**

**Dues payments and contributions are not deductible as charitable contributions for federal income tax purposes. Dues payments (or a portion) may be deductible as a miscellaneous itemized deduction.**

Annual national membership dues include \$4.65 for NEA TODAY, \$2.50 for the AMERICAN TEACHER, \$1.75 for the AMERICAN EDUCATOR, and/or \$19.00 for the Higher Education publications. Annual dues to EDUCATION MINNESOTA include a \$10.00 contribution to the Political Fund, a \$5.00 contribution to the Foundation for Excellence in Teaching & Learning, and an annual subscription rate of \$5.00 for the MINNESOTA EDUCATOR. The nature of the publications received by members is based on membership category.

**POLITICAL FUND:** The Education Minnesota Political Fund collects contributions from members and uses those contributions to help elect friends of education to public office. Annual contribution of \$10.00 is requested, which is included in your dues. Unless you exercise your right to a refund, this contribution will be made on your behalf. This amount may be adjusted up or down in future fiscal years by action of the Representative Convention.

The member must mail the Refund Request Form to the Education Minnesota Accounting Department postmarked or hand delivered within thirty (30) days of signing this application form. The Education Minnesota Political Fund will mail a refund check within thirty (30) days after receipt of the Refund Request Form. Only the official Refund Request Form will be accepted by the Political Fund. Photocopies of the form will not be accepted.

**FOUNDATION FOR EXCELLENCE IN TEACHING & LEARNING:** The Foundation supports and promotes initiatives that improve access to learning and excellence in teaching in the form of grants and training that benefit members.
